The Future of Marine Safety and Sustainability with Flare Collection Events

This fall, multiple coastal jurisdictions across California are partnering with state organizations to host expired marine flare collection events. These events aim to tackle one of the pressing environmental issues faced by boaters—proper disposal of single-use pyrotechnic marine flares.

The Challenge of Disposing Pyrotechnic Flares

Pyrotechnic marine flares, essential for every boater's safety kit, unfortunately pose significant environmental challenges. Classified as hazardous waste due to their toxic chemicals, including perchlorate, these flares require careful handling and disposal. Yet, with limited disposal facilities in the country, the cost of safe disposal ranges from \$10 to \$50 per flare, a burden often leading to improper disposal methods. Consequently, many end up in household trash or, worse, thrown into our waterways, contaminating environments and endangering human health.

Paving the Way for Future Marine Safety Legislation

Although Governor Gavin Newsom vetoed SB1066, the Marine Flare Manufacturer Responsibility Act, it represented a crucial initial step in tackling the pressing issue of safely disposing of expired marine flares. The bill highlighted the environmental hazards associated with hazardous pyrotechnic flares and paved the way for future legislative initiatives. With robust support from environmental advocates and lawmakers, a solid foundation has been established for a more comprehensive plan, which can be developed in partnership with the Department of Toxic Substances Control (DTSC). Looking ahead, stakeholders remain optimistic about forthcoming legislation that will better protect both boaters and the environment while providing effective oversight and enforcement.

Upcoming Flare Collection Events

Recognizing the current lack of ongoing disposal programs, California's Coastal Commission, along with California Coastal Commission, CalRecycle, and California State Parks, is organizing a series of collection events to provide temporary relief. These events will not only facilitate the safe disposal of expired flares but also educate participants about the advantages of reusable electronic distress signals, or eVDSDs, as an alternative.
