OVERVIEW

The California Product Stewardship Council (CPSC) has established itself as a trailblazer in textile recycling. They have a proven track record of success in leading fiber identification device demonstrations across the state, in addition to their pivotal role in piloting initiatives such as the Los Angeles Sanitation and Environment (LASAN) pilot program. CPSC is sponsoring SB 707, introduced by Senator Josh Newman, which could potentially set a global precedent for textile reuse, repair, and recycling.

On April 9th, 2024, CPSC hosted a Textile Recycling Event in collaboration with Santa Barbara RMDZ. This event highlighted the Santa Barbara and Southern California textile network, including professors, brands, recyclers, upcyclers, Wishtoyo tribe members, and community members interested in the world of fibers. The day's activities included speakers, vendors, and device demonstrations, all meant to foster connection and education about textile recycling opportunities in Santa Barbara and beyond.

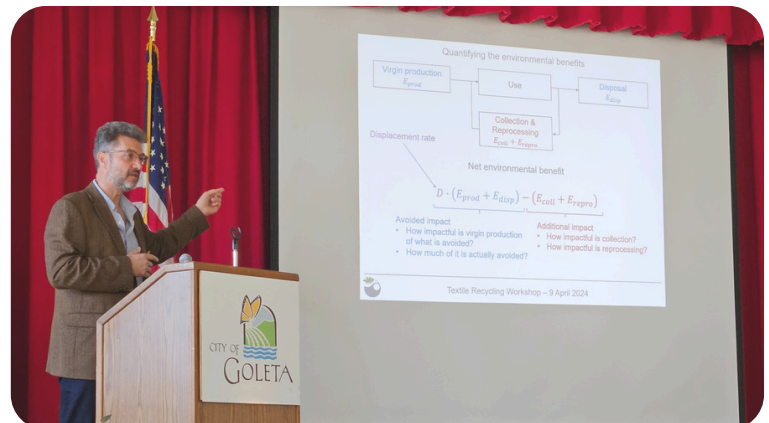

Santa Barbara can find partners to expand collection for textile waste. Sustainability goals set by regional brands align with local government waste diversion goals. Brands should be encouraged to buy recycled fibers from So Cal. This is especially important for the LA28 Olympics in LA.

CA
